**Dear Members of the World Minigolf Sport Federation,**

This is the annual call for members' projects.

WMF receives ball license fees from ball producers and a part of these revenues is reserved for projects of WMF members. For details, see chapter 3.4 of WMF Rulebook ([http://www.minigolfsport.com/rules/3\\_4.pdf](http://www.minigolfsport.com/rules/3_4.pdf))

Applications for projects which serve minigolf sport promotion and/or minigolf development (especially in new member countries) are welcome. Please note that due to the limitation of the funds WMF cannot grant financial support to buy minigolf courses, or to set-up a complete infrastructure.

Examples of previously supported projects (non-exhaustive list):

- Established national association member helps new active members and/or candidate members
- Membership for affiliation with national sports organisation
- Building up regional and local sports structures
- Referee and coach education offered by WMF to small and developing members
- Establishing new local minigolf schools (especially for youth)

Other projects are welcome as well. Only members who have assigned marketing rights to the WMF are entitled to financial support for projects. Priority is given to new members.

In order to get a financial support for 2015 please submit your project application **by July 27, 2015 to the WMF Headquarters**. Decisions will be made by the WMF Board Meeting on August 15, 2015.

Your project brief should be drafted on one to two pages containing:

- A detailed description of your project
- The total detailed budget of the project
- Application for financial support (i.e. amount you expect from WMF, but not more than EUR 1000)
- Contact details of person responsible for the project (including phone numbers, e-mail)

WMF should be widely promoted during the project by placing WMF logos on banners, printing materials, during any promotion actions and during the program itself, etc. For further information or guidance, please contact the WMF Marketing and Media Committee.


Within 30 days after the project, you should be ready to provide to WMF:

- Photo and / or video materials
- Financial report

Without these materials, WMF cannot guarantee financial support even if it was preliminary decided and agreed by the Board. WMF reserve the right to ask for project press releases or other materials to be drafted by the funding recipient.
